If you find any defect with the Cover Or Interior Design products while printing the Cover Designs the defect will be rectified if what appears to be a defect is actually a defect according to RWSP as well and the rectification is possible. - 4.Limited Iterations of Design modifications are permissible as per the comments provided by the customer to modify the design in certain manner after RWSP has completed the design.
